Fiscal Year 2021: Quarter 1

The purpose of this quarterly report is to provide insight into the potential, ongoing, and awarded actions under the ProTech Program. ProTech includes a suite of multiple award indefinite delivery, indefinite quantity contracts covering four domains: Satellite, Fisheries, Oceans, Weather. The shared ceiling dollar amount for orders under all ProTech Domains is \$3,000,000,000.00.

Chart 1: Awards (% by \$)

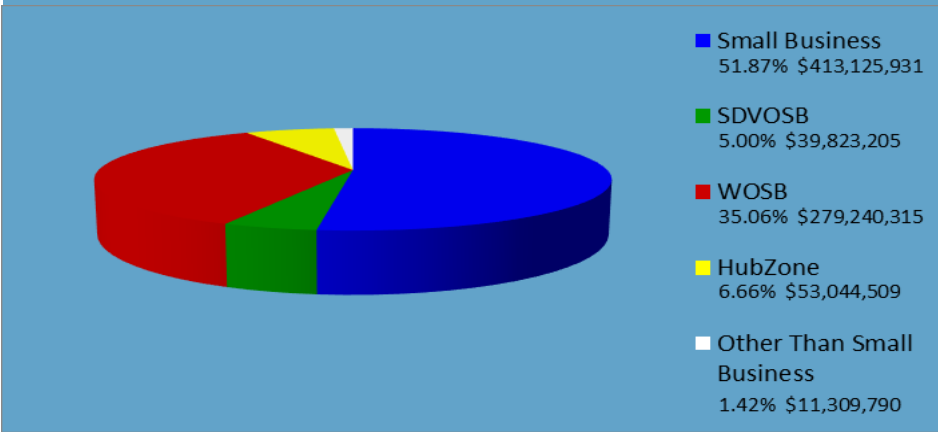
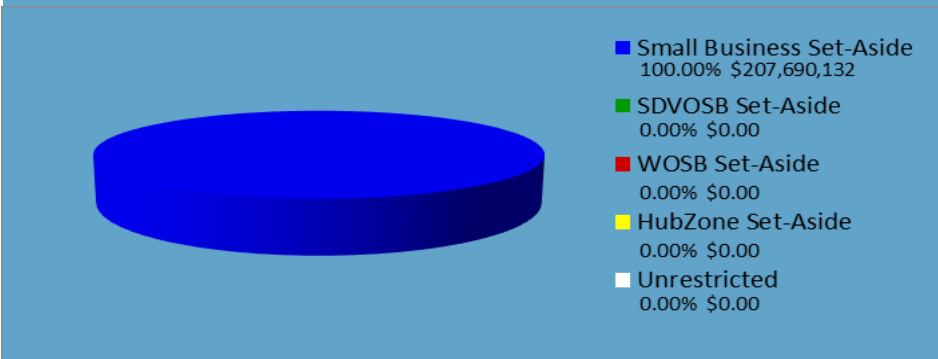


Chart 2 is an overview of the set-aside determination for task orders currently under solicitation or evaluation.

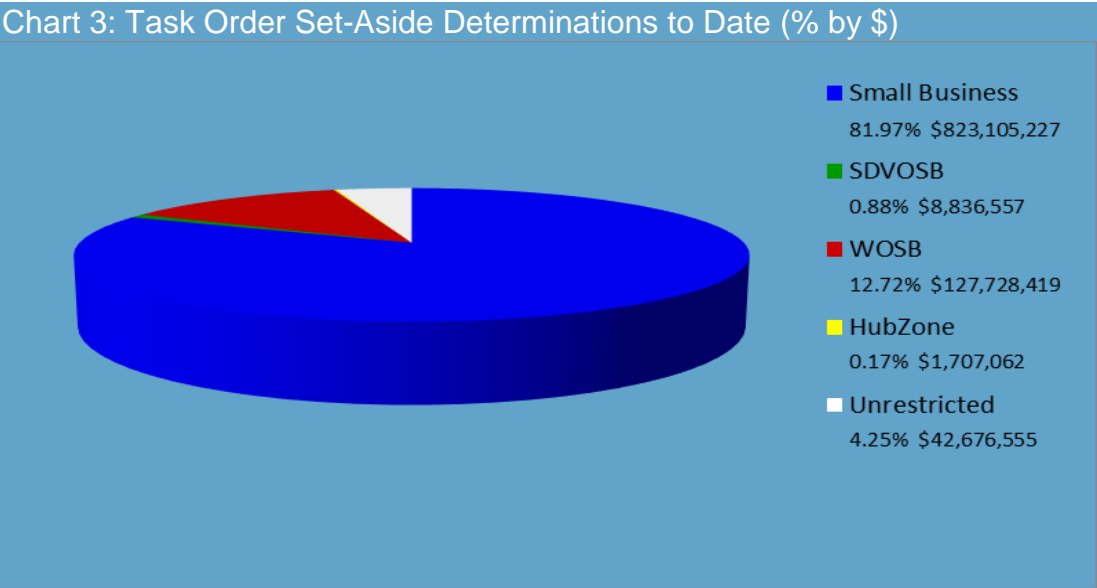
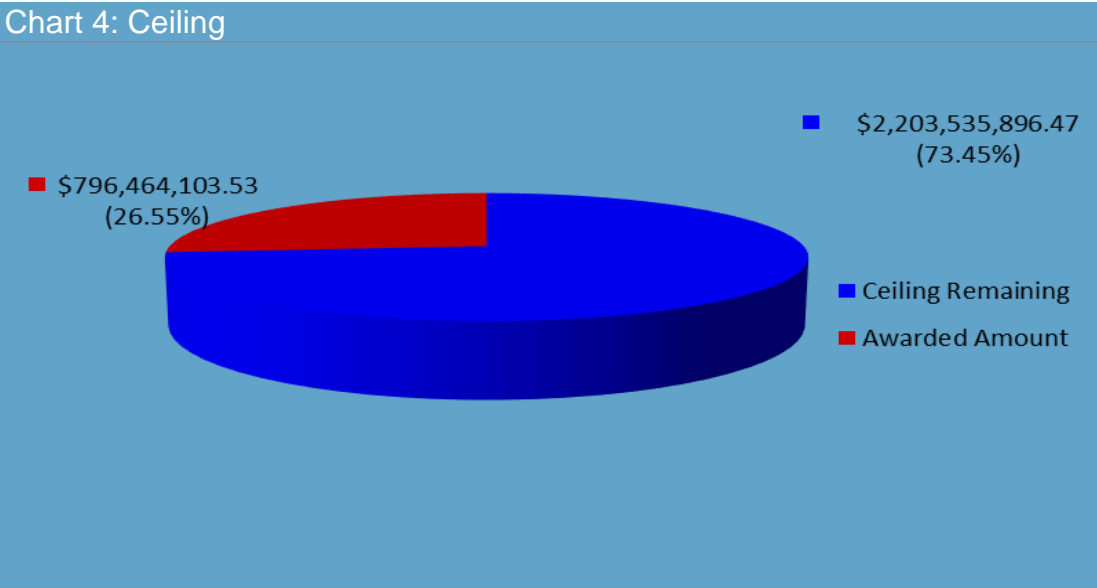

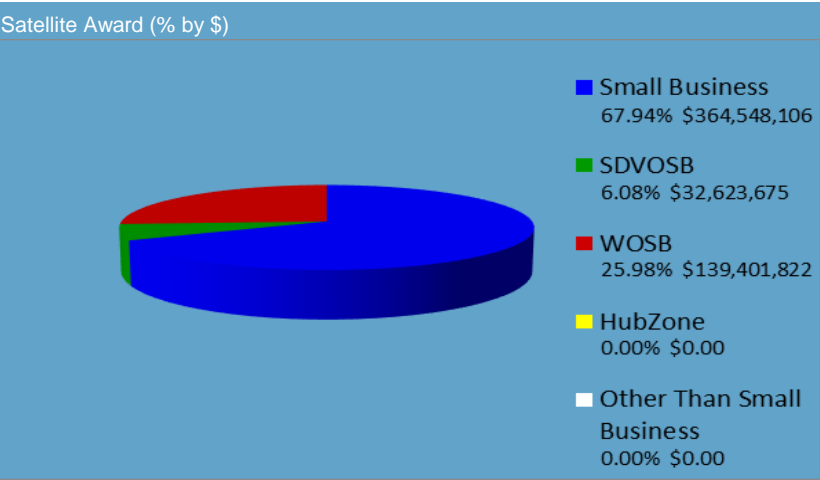


Chart 7 provides an overview of the Oceans Domain task order awards accomplished to date by socio-economic status.

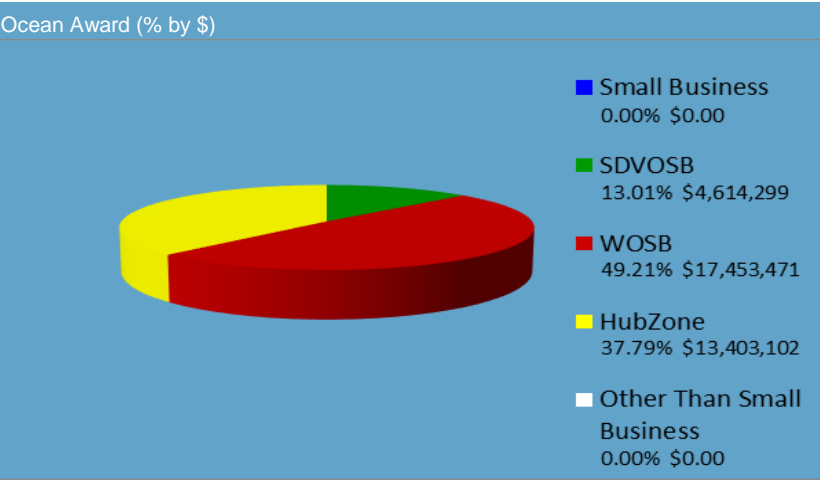


Chart 6 provides an overview of the Fisheries Domain task order awards accomplished to date by socio-economic status.

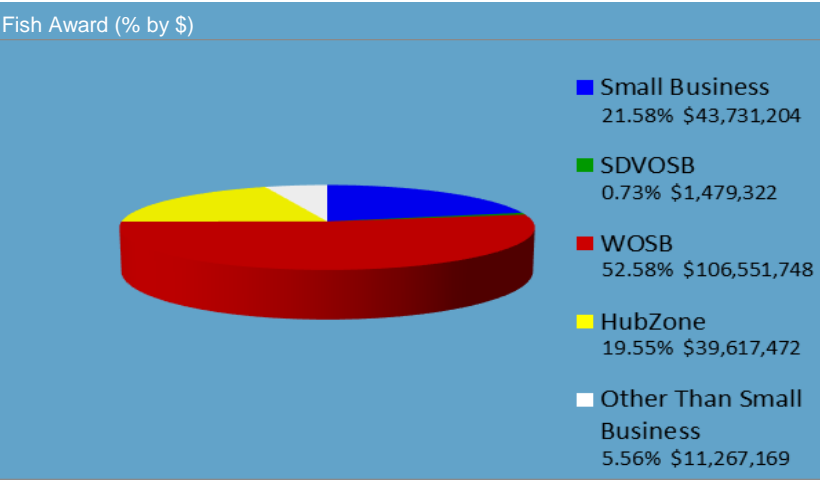


Chart 8 provides an overview of the Weather Domain task order awards accomplished to date by socio-economic status.

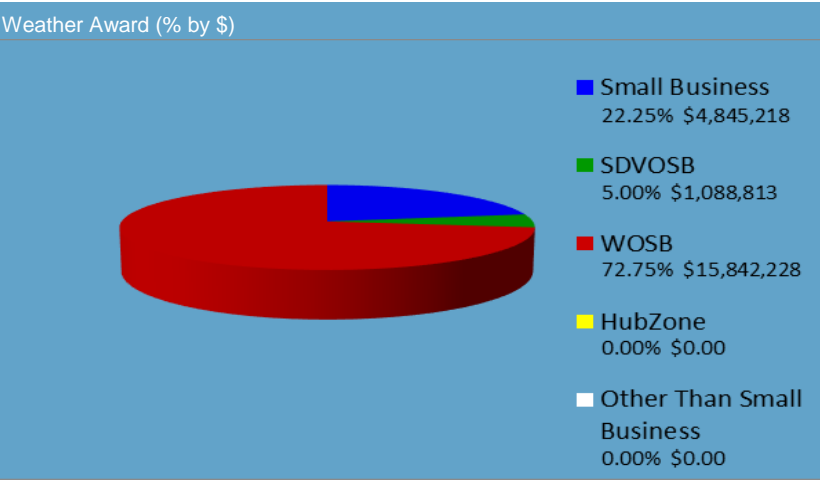
